

Special Terms and Conditions

1. We require Tendered Equipment from any one of the following Owner's approved makes only.

- a) M/s WARTSILA
- b) M/s CATERPILLER,
- c) M/s YANMAR
- d) M/s ABC

The offers other than the above makes will be rejected. In case, the bid submitted through dealers / agents, authorized dealership certificate / agents' ship agreement shall be enclosed with the offers without which the offer will not considered for finalization of order.

2. **Tender due date for opening of technical Bids (Part 1):** 30 days from the date of issue of tender i.e., up to 3rd Oct, 2011.

3. **Delivery schedule:** for VC 11173: 31-Mar-2012
VC 11174: 30-Jun-2012

4. **Delivery Terms:**

a) **Indigenous suppliers:** Free Delivery to HSL STORES, Visakhapatnam including packing forwarding & insurance charges

b) **Foreign suppliers:** CIF, Visakhapatnam. However, freight charges and insurance charges shall be indicated separately in the price offer. (Please note that the insurance shall be covered from supplier warehouse to HSL warehouse)

5. **Taxes:** All the applicable duties & taxes viz., TDS, Sales tax, Service Tax etc., with in India & foreign (if any) shall be indicated clearly.

6. **Inspection and commissioning:** 20 working days in three trips, onsite Service Engineer assistance for start-up and commissioning for Main Engines in yard shall be provided as per Technical specifications. Service Engineer shall complete the commissioning works with in stipulated time. However, in the event of excess man days due to the reasons not attributable to the contractor, per diem rate of Service Engineer (including to & fro airfare, boarding & lodging charges and local conveyance charges, TDS & Service tax etc.,) may be furnished in the offer for HSL consideration.

7. **Performance Bank Guarantee:** Successful bidders are required to furnish Performance Bank Guarantee as per the format placed in HSL web site at Annexure –III, through any Nationalised Bank in India, for 10% value of order within 10 days from the date of receipt of order. PBG shall cover the warranty period of materials.

8. **Guarantee/warranty of materials:** 30 months from the date of supply of materials or 12 months from the date of handing over of vessel to the Owners, whichever is earlier.

9. **Validity period:** Validity of offer shall be 120 days from date of opening of tender and same shall be extended further for certain period (if required) to enable to finalize the matter.
10. **Price:** Vendors are requested to indicate the prices of spare parts inclusive of class recommended spares, tools & charges for onboard training etc., as per technical specifications and all applicable taxes (if any) separately in price bids.
11. Tender Fee: - 1500/-.
 - a) Tender Fee amount as indicated above shall be collected in the form of DD in favour of crossed demand draft / pay order in favour of HSL, payment invishakhapatnam and should be enclosed to part – I / offer from bidders who down load the tender enquiry from HSL website.
 - b) HSL shall not responsible for non receipt or delays in receipt of tender enquiry by any of the bidders. Bidders in their own interest should ensure that they receive the tender enquiry in time.
12. It may be noted that confirmation of all the technical specifications, Commercial Questionnaire (Indigenous / foreign), HSL standard terms & conditions & special terms & commercial terms and conditions is mandatory. All the tender documents as above shall be filled & duly signed by the supplier.
