The validity of the PBG should be for a period of 12 months from the date of completion of the contract. 16	Rejection Criteria	The offers of the Parties, who do not full fill the requirements at to S.No 7, 8,9,13 & 14 are liable for rejection. No bill adjustment towards EMD IS PERMITTED.
17	Payment Terms	100% on account payment will be released on submission of the invoice together with work completion certificate duly certified by Production and Quality Control departments.
18	Schedule completion of Works	Work should be completed with in 3 months from the date of issue of firm order.
