

TENDER DOCUMENT

Dt: 12th August, 2010.

Sealed quotations are invited from Reputed Hoteliers having 3 Star Grading for supply of superior quality of food preparations comprising of Breakfast, N.V.Lunch, Coffee/Tea, Biscuits and Frooti Drinks & Veg. Dinner on board the ship during seatrials for about 100 to 200 persons a day. The details of food services are indicated in the ANNEXURE.

1. The tenure of contract will be for 3 years. The requirement of catering services will be ranging from 4 to 12 occasions in a year and the rates quoted shall be firm during the period of contract.
2. The supply of food shall be made as and when required by HSL with 24 Hrs. prior intimation on turnkey basis.
3. In the event of cancellation/postponement of sea trials due to unforeseen circumstances, HSL reimburse the cost of food items i.e., perishable items only. The Hotelier has to take back the raw items (non-perishable) from HSL premises on intimation from HSL.
4. HSL reserves the right in finalization of tenders basing on the experience, reputation and infrastructure of Hoteliers in providing high quality and standard food.
5. HSL reserve the right to terminate/cancel the contract incase the services are found to be not satisfactory. Further, the contract can be terminated with 2 months notice on either side.
6. EMD Deposit for Rs.15,000/- by way of Demand Draft drawn from any nationalized bank in favour of Hindustan Shipyard Ltd., which is refundable at the end of contract. Quotation received without EMD, unsigned Tender document, late bids are liable for rejection.
7. The bidder has to submit a certificate issued by competent authority in proof of 3 Star Grading.
8. HSL reserves the right either to accept or to reject the tender without assigning any reasons.
9. Incase the party fails to execute the order to the satisfaction of HSL, HSL reserve the right to cancel the contract and get the assignment completed by other party at the cost and risk of existing party.

10. Payment Terms:-
100% payment shall be released after one month from date of submission of bills duly certified by component authority.
11. Any statutory levies such as Tax deduction at source, etc., will be deducted from the bill.
12. JURISDICTION:-
The enforcement of the terms and conditions as well as all the transaction entered into by the contractor with the company shall be deemed to have been taken place within the jurisdiction of Visakhapatnam Court where the works are stipulated and any cause of action arising to the due performance or breach of contract by either of the parties hitherto shall be deemed to have arisen within the jurisdiction of Visakhapatnam notwithstanding the residence or place of business of the contractor.
13. ARBITRATION:-
All disputes between the parties shall be referred to the sole arbitration/Chairman, Hindustan Shipyard or a person to be appointed by the C&MD and if the arbitrator so appointed resign his appointment or vacates his office or he is unable to and unwilling to act due to any reasons what so ever to authority appointing him may appoint a new arbitrator to act in his place. The arbitrator so appointed may from time to time with the consent other parties endorse the period of the time for making and publishing the award. The arbitrator shall all matters referred to him indicate his findings along with the sums awarding separately on each individual item of disputes and venue of arbitration shall in all cases subject to the convenience of the arbitrator be Visakhapatnam only. The award of the arbitrator shall be final and binding subject to the provisions Indian Arbitration and Reconciliation Act, 1996.
14. The HSL standard Terms & conditions are applicable.
15. The party has to submit the quotation along with this Tender Document duly signed.
